Purpose:


Provide financial assistance to (PSUs) and schools with high numbers or high percentages of children from lowincome families to help ensure that all children meet challenging state academic standards Schools at or above 35% poverty may be served; Schools at or above 75% poverty must be served.

Poverty rates were generated by the Franklin County Schools Meals Plus Student Eligibility Report.

All schools in the district exceeded the 35% poverty rate.

All elementary and middle schools will be served.



Purpose

- 1) Increase student academic achievement through strategies such as improving teacher and principal quality and increasing the number of highly qualified teachers in the classroom and highly qualified principals and assistant principals in schools; and
- (2) Hold LEAs and schools accountable for improvements in student academic achievement

Use of Funds (Data driven & Based upon Needs)

Supports teacher recruitment efforts and new teacher supplemental supports (i.e. BT NC New Teacher Support Program)

Provides targeted professional development for content specific groups (i.e. principals, assistant principals, EC teachers, AIG teachers, and curriculum leads)

Supports continuous learning through educational reimbursement program for alternatively licensed individuals and teacher assistants

Supports the New Teacher Coordinator position

Supplemental retention efforts (i.e. stipends)
