Open Bid requests were sent out and publicized for reputable Milk vendors. On May 3, 2023 the Milk Bid opening was held and out of the 2 Bids submitted Maola Milk won the Fix Fee Bottom Line Bid for the 2023-2024 School Year.

Tonight I am seeking FCS Board of Ed to approve the 2023-2024 Milk Bid for Maola Dairy with a forecast spending of \$143,900.00



# Lot 4 Produce

**Request for Renewal with R&H Produce**

**Denied**

With the request for Renewal it locks in these fees for another school year.

When the request was made to R&H Produce to renew for another year they denied my request due to change in pricing terms. Due to the change request of the current contract FCSN had to do an Open Bid process.

Open Bid request were sent out and publicized for reputable Produce vendors. On May 18, 2023 the Lot 4 Produce Bid opening was held and out of the 3 Bids submitted R&H Produce won the Fix Fee Bottom Line Bid for the 2023-2024 School Year.

Tonight I am seeking FCS Board of Ed to approve the 2023-2024 Lot 4 Produce for R&H Produce with a forecast spending of \$177,927.00 w/ \$5.35 cs. delivery fee.
